### **Harley Davidson Club Gibraltar Prospective Membership Application**

On behalf of the Harley Davidson Club - Gibraltar Committee, we thank you for applying to become a member of our Club.

This document serves as a guideline to the procedure involved in applying for membership. Should you have further queries regarding application or membership, please contact any member of the committee (your proposer or seconder will be able to guide you). Kindly note the following:

#### **APPLICATION PROCESS**

1. All persons wishing to join the club must be proposed by an Ordinary or Honorary Life member and seconded by another, both of whom shall have been members of the club for not less than twelve months and be in good standing.
2. The attached Membership Application Form is to be fully completed and handed or mailed to the clubs' committee.
3. You are requested to ensure that two colour identity photographs accompany your application document.
4. Your name, together with a photograph will be placed on the Notice Board for the duration of your scrutiny period after which your application will be subjected to ballot by the General Committee for final acceptance.

#### **SCRUTINY PERIOD**

All prospective members will be subject to a three months scrutiny period:

Any member having any information which s/he considers relevant to such application shall be entitled to bring such information to the attention of the General Committee within a fourteen day period. The provisions of this clause shall not apply to Temporary Members.

During your scrutiny period you will be considered a Temporary Member of the club. The committee will advise you in writing of your status.

As a Temporary Member you are encouraged to enjoy full use of Club facilities and join in our club activities.

#### **MEMBERSHIP BALLOT**

On completion of your scrutiny period, the final approval of your full membership shall be vested in the Committee, who shall vote by ballot.

Following the ballot you will be contacted by the committee who will advise you of the result of said ballot.

Should your application be unsuccessful, the Committee shall not be obliged to furnish reasons for such decision. A rejected candidate may not be re-proposed for at least twelve months after his rejection.

### **Subscription Fees**

Please note that our Membership Year commences on the 1st January each year. All subscription fees shall therefore fall due on that date and shall be paid in full within thirty calendar days of due date.

Prospective members elected to membership during the course of the year will not be entitled to paying a *pro rata* share of the annual subscription i.e. full joining fee of £30 will be payable on joining regardless of which month of the year this may be. Thereafter an annual membership fee of £25 will be payable in January of every successive year. Joining fee will entitle member to full club privileges, clubs colours, t-shirt and pin.
